Abstracts

This report was created for global strategic planners who cannot be content with traditional methods of segmenting world markets. With the advent of a 'borderless world', cities become a more important criteria in prioritizing markets, as opposed to regions, continents, or countries. This report covers the top 2,000 cities in over 200 countries. It does so by reporting the estimated market size (in terms of latent demand) for each major city of the world. It then ranks these cities and reports them in terms of their size as a percent of the country where they are located, their geographic region (e.g. Africa, Asia, Europe, Middle East, North America, Latin America), and the total world market.

This study covers rubber and plastic transmission belts and belting excluding flat belts and belting as defined by the North American Industrial Classification system or NAICS (pronounced 'nakes').

The NAICS code for rubber and plastic transmission belts and belting excluding flat belts and belting is 3262202. It is for this definition that aggregate latent demand estimates are derived. Rubber and plastic transmission belts and belting excluding flat belts and belting is specifically defined as follows:

3262202 Rubber and plastics transmission belts and belting, other than flat

32622021 Motor vehicle rubber and plastics transmission belts and belting other than flat

32622022 All other rubber and plastics belts and belting other than flat



3262202125 Motor vehicle rubber and plastics transmission belts and belting other than flat

3262202231 Industrial (excluding fractional horsepower) rubber and plastics transmission belts and belting other than flat

3262202245 All other rubber and plastics belts and belting, including agricultural and fractional horsepower, other than flat
