Abstracts

This report was created for global strategic planners who cannot be content with traditional methods of segmenting world markets. With the advent of a 'borderless world', cities become a more important criteria in prioritizing markets, as opposed to regions, continents, or countries. This report covers the top 2,000 cities in over 200 countries. It does so by reporting the estimated market size (in terms of latent demand) for each major city of the world. It then ranks these cities and reports them in terms of their size as a percent of the country where they are located, their geographic region (e.g. Africa, Asia, Europe, Middle East, North America, Latin America), and the total world market.

This study covers scouring and combing yarn spinning mill products as defined by the North American Industrial Classification system or NAICS (pronounced 'nakes').

The NAICS code for scouring and combing yarn spinning mill products is 313111C. It is for this definition that aggregate latent demand estimates are derived. Scouring and combing yarn spinning mill products is specifically defined as follows:

313111C Scouring and combing mill products

313111C1 Scouring and combing mill products

313111C111 Scouring and combing mill products, tops and noils, including top or sliver converted from tow without combing

313111C112 Top production, wool of sheep (domestic and foreign), 60s and finer

313111C115 Top production, wool of sheep (domestic and foreign), coarser than 60s

313111C119 Top production, all other fibers (except wool of sheep), including mohair

313111C121 Scouring and combing mill products, scoured wool and other scouring and combing mill products, including nubs and slubs, etc.

313111C122 Noil production, wool of sheep (domestic and foreign), 60s and finer

313111C125 Noil production, wool of sheep (domestic and foreign), coarser than 60s

313111C129 Noil production, all other fibers (except wool of sheep), including mohair
