Abstracts

This report was created for global strategic planners who cannot be content with traditional methods of segmenting world markets. With the advent of a 'borderless world', cities become a more important criteria in prioritizing markets, as opposed to regions, continents, or countries. This report covers the top 2,000 cities in over 200 countries. It does so by reporting the estimated market size (in terms of latent demand) for each major city of the world. It then ranks these cities and reports them in terms of their size as a percent of the country where they are located, their geographic region (e.g. Africa, Asia, Europe, Middle East, North America, Latin America), and the total world market.

This study covers whole wheat, durum, semolina, bulgur, farina, and other wheat flour made in flour mills excluding flour mixes as defined by the North American Industrial Classification system or NAICS (pronounced 'nakes').

The NAICS code for whole wheat, durum, semolina, bulgur, farina, and other wheat flour made in flour mills excluding flour mixes is 31121118. It is for this definition that aggregate latent demand estimates are derived. Whole wheat, durum, semolina, bulgur, farina, and other wheat flour made in flour mills excluding flour mixes is specifically defined as follows:

31121118 Whole wheat, durum, semolina, bulger, farina, and other wheat flour, except flour mixes, made in flour mills

31121118C1 Whole wheat flour, made in flour mills



31121118D1 Durum flour and semolina, made in flour mills

31121118D2 Straight semolina and durum flour

31121118D5 Blended semolina and durum flour

31121118F1 Other wheat flour, including farina, made in flour mills

31121118E1 Bulgur flour, made in flour mills
