## **Abstracts**

This report was created for global strategic planners who cannot be content with traditional methods of segmenting world markets. With the advent of a 'borderless world', cities become a more important criteria in prioritizing markets, as opposed to regions, continents, or countries. This report covers the top 2,000 cities in over 200 countries. It does so by reporting the estimated market size (in terms of latent demand) for each major city of the world. It then ranks these cities and reports them in terms of their size as a percent of the country where they are located, their geographic region (e.g. Africa, Asia, Europe, Middle East, North America, Latin America), and the total world market.

In this report we define the sales of yeast ingredients as including all commonly understood products falling within this broad category, such as yeast extract, autolyzed yeast, yeast cell wall, and yeast-based flavor ingredients; ingredients used for food, feed and pet food, and pharmaceuticals; and ingredients from baker's and brewer"s yeast, irrespective of product packaging, formulation, size, or form. Companies participating in this industry include AB Vista, Alltech, Anchor Yeast, Angel Yeast Company, Archer Daniels Midland Company, Associated British Foods, Becton, Dickinson and Company, Beldem, Bevenovo Company, Ltd., Cangzhou YaTai Commercial & Trade Company, Ltd., Cargill, Chr. Hansen Holding, DSM, Foodchem International, Kerry Group, Koninklijke DSM, Lallemand, Leiber, Lesaffre, Organotechnie, Sensient Technologies Corporation, Suboneyo Chemicals Pharmaceuticals Pvt, Ltd., Synergy Flavors, and Tangshan Top Bio-Technology Company. In addition to the sources indicated, additional information available to the public via news and/or press releases published by players in the industry was considered in defining and calibrating this category. All figures are in a common currency (U.S. dollars, millions) and are not adjusted for inflation (i.e., they are current



values). Exchange rates used to convert to U.S. dollars are averages for the year in question. Future exchange rates are assumed to be constant in the future at the current level (the average of the year of this publication's release in 2022).
