Abstracts

This study covers the world outlook for C5-C8 normal paraffins across more than 190 countries. For each year reported, estimates are given for the latent demand, or potential industry earnings (P.I.E.), for the country in question (in millions of U.S. dollars), the percent share the country is of the region, and of the globe. These comparative benchmarks allow the reader to quickly gauge a country vis-à-vis others. Using econometric models which project fundamental economic dynamics within each country and across countries, latent demand estimates are created. This report does not discuss the specific players in the market serving the latent demand, nor specific details at the product level. The study also does not consider short-term cyclicalities that might affect realized sales. The study, therefore, is strategic in nature, taking an aggregate and long-run view, irrespective of the players or products involved.

In this report we define the sales of C5-C8 normal paraffins as including all commonly understood products and/or services falling within this broad category, irrespective of product packaging, formulation, size, or form. Companies participating in this industry include Air Liquide, Beyond Industries (China), Bharat Petroleum Corporation, BP, Calumet Specialty Products Partners, China Petroleum & Chemical Corporation (SINOPEC), Compania Espanola de Petroleos, Compañía Española de Petróleos (CEPSA), Ergon, Exxon Mobil Corporation, Indian Oil Corporation, Jilin Beihua Fine Chemical Company, Junyuan Petrochem Group, Liaoning Yufeng CHEMICAL Company, Linde AG, Neste, Oil Co. Lukoil, Petrobras, Phillips 66 Company, PJSC LUKO, Puyang Zhongwei Fine Chemical Company, Rompetrol Rafinare S.A. (Romania), Royal Dutch Shell, Sasol, Sinopec, Thai Oil Public Company, and The Linde Group. In addition to the sources indicated, additional information available to the public via news and/or press releases published by players in the industry was considered in defining and calibrating this category. All figures are in a common currency (U.S.

dollars, millions) and are not adjusted for inflation (i.e., they are current values). Exchange rates used to convert to U.S. dollars are averages for the year in question. Future exchange rates are assumed to be constant in the future at the current level (the average of the year of this publication's release in 2024).
