The global data protection-as-a-service (DPaaS) market size reached US\$ 20 Billion in 2021. Looking forward, IMARC Group expects the market to reach US\$ 87 Billion by 2027, exhibiting a growth rate (CAGR) of 27.87% during 2022-2027. These systems use virtualization tools, such as a virtual private network (VPN), firewalls and hypervisors, to remotely monitor the physical network of the organizations. They also facilitate long-term retention of archival data and quick recovery of the data-in-transit and data-at-rest.

The increasing virtualization of information technology (IT) infrastructure across the globe represents one of the key factors driving the growth of the market. such as the integration of connected devices with the internet of things (IoT) and virtual private network (VPN), are acting as other major growth-inducing factors. DPaaS is installed on IoT-enabled devices to encrypt, store and secure large volumes of data generated by individuals and organizations with enhanced operational efficiency and data resiliency. Other factors, including significant improvements in the IT infrastructure, along with extensive research and development (R&D) activities, are anticipated to drive the market further.
