As in the market by type is segregated into rectal suppositories, vaginal suppositories and urethral suppositories. The rectal suppository generated the highest revenue in the Pharmaceutical suppositories market growth. This can be ascribed to the rise in focus on the development of rectal suppository.

On the basis of base, the segmentation is classified as the water-miscible base (soap glycerin suppositories, polyethylene glycol bases, and glycerol gelatin base), fatty bases, and emulsifying bases (Massa esterium, witepsol, and massuppol). The emulsifying bases have leaded the base segment with maximum share. Since, emulsifying bases solidify quickly, are nonirritant, and are less liable to get rancid.

On the basis of end-user segment the pharmaceutical suppositories market is segmented into hospitals & clinics, nursing homes, and home care. Where, the hospitals & clinics segment has observed the highest revenue in the market. This is because of the rising inclination of hospitals towards pharmaceutical suppositories to instantly treat pediatric or old patients.
