## Abstracts

### KEY FINDINGS

Although the Asia Pacific Surgical/Operating Microscopes Market accounted for the third-highest revenue share in 2017, it is expected to catapult ahead over other markets during the forecast period of 2018-2026 in terms of CAGR. Between these projected years, an 11.34% CAGR is anticipated from this market.

### MARKET INSIGHTS

Several emerging economies such as Australia, India, Japan, and China are contributing to this region's progress. In 2017, China dominated the APAC surgical/operating microscope market. The adoption of surgical /operating microscope in ophthalmic healthcare facilities is mainly responsible for this market's prosperity. However, the overall growth of the Asia-Pacific surgical/operating microscopes market is being challenged by factors like high cost of advanced operating microscopes and the lack of skilled professionals in the region.
