The European market is classified on the basis of application, types and harvesting and fixation devices. The market is driven by rising health expenditure in countries such as the United Kingdom and France. This includes expenditures on health insurance being offered by government and private health insurance companies, which, in turn, is boosting the demand for the bone grafts and substitutes for surgeries such as joint reconstruction, bone implants, and hip replacements. Of all the European countries, the German market is expected to witness the highest CAGR growth. The country is the third largest medical technology market globally, after the United States and Japan.
