### **Abstracts**

Attempts are made to curtail activities that are against the law of the land by different governments by tracking communication channels. The use of Smartphones, tablets, etc. to execute terror attacks has compelled world leaders to take LI technology on a serious note. Due to the above mentioned aspects, the grafting LI technologies into the security framework will be inevitable in the foreseeable future.

The extensive use of internet has led to increasing criminal activities in the North American region. Email is been used to communicate with associated groups to bring criminal activities to reality. Filtering right and valid information is a major challenge when emails are used to communicate; therefore, LI activities become an inevitable part of the law enforcement agencies.

US government has joined hands with Verint to build a lawful interception tool for AFI. The tool has the capability to interpret communication from SMS, landline calls or internet. Verint had designed a centralized system to monitor calls and store data for a longer duration. The tool helps in preparing the warrant to the preparation of evidence. There are many other software solutions that are highly effective in locating, and tracking activities real time.

The North America Lawful Interception Market is bifurcated based on Solutions, Components, Network Technology, Communication Technology and End User. Voice-Over-Internet Protocol (VoIP), Wireless local area network (WLAN) and Worldwide Interoperability for Microwave Access (WiMax) are the major types of network technologies available for the lawful interception market.



Routers/switches, handover interfaces, interception access point, mediation devices, management server, etc. are components analyzed within the scope of the report.

In 2015, the Devices segment dominated the North American lawful interception market. Based on estimation, the segment would contribute a revenue share of 44% in 2016, and is expected to grow at a CAGR of 17.9% throughout the forecasted period.

Based on region, Lawful Interception market is segmented across the countries including U.S., Canada, Mexico and Rest of North America. In 2015, the U.S. region dominated the North American lawful interception Mediation Devices market. Based on estimation, the region would contribute a revenue share of 31.4% in 2016, and is expected to grow at a CAGR of 19.2% by 2022. Canada on the other hand is expected to register a highest CAGR of 21.9% during the forecast period (2016-2022).

North America lawful interception Mobile Data Communication market is expected to grow at a CAGR of 16% during the forecasted period. The Government segment would continue to dominate as End User throughout 2022 and is expected to grow at a CAGR of 22.9%.
