The global Cosmetic Care Testing market size is predicted to grow from US\$ 2549 million in 2025 to US\$ 4265 million in 2032; it is expected to grow at a CAGR of 7.8% from 2026 to 2032.

Cosmetic care testing refers to a comprehensive set of experimental processes that systematically evaluate the safety, efficacy, and user experience of skincare, haircare, and other cosmetic products under real or simulated use conditions. It typically includes: basic safety testing (such as irritation and allergy assessment), human efficacy testing (such as effects like moisturizing, whitening, firming, oil control, and barrier repair, using instruments like Transepidermal Water Loss (TEWL), stratum corneum moisture content, and skin tone analyzers, along with subjective evaluations via questionnaires), long-term use tracking, and necessary stability and packaging compatibility testing. Through cosmetic care testing, brands can verify the validity of their claims (such as '24-hour moisturizing' or 'improves fine lines'), reduce the risk of adverse reactions, and provide data support for product registration, advertising claims, and marketing promotion.

From the demand side, cosmetics and skincare testing has evolved from simply 'proving that you're not a scammer' to a 'rigid link in efficacy claims and brand premium.' On one hand, regulations are becoming stricter—China's registration and random inspections, efficacy claim standards, and safety compliance requirements in Europe and the United States are all forcing brands to provide quantifiable and traceable test data. On the other hand, consumers are becoming increasingly knowledgeable: they can read ingredient lists, question advertisements promising 'effectiveness in XX days,' and browse test reports on social media. As a result, mid-to-high-end brands struggle to justify high prices and maintain a 'professional, safe, and effective' image without

substantial human efficacy testing, instrumental testing, and long-term usage evaluations. Even many emerging brands are starting to incorporate 'efficacy test passed' and 'third-party data' into their marketing rhetoric. It can be said that skincare testing has quietly transformed from a cost center into a cost of brand trust and a customer acquisition tool.

From the supply side, this sector is shifting from a model of 'small labs + simple efficacy verification' to one of 'professional CROs + standardized testing combinations.' On one hand, building a complete testing system in-house is costly and time-consuming, making it impractical for small and medium-sized brands. Consequently, a large demand flows to third-party testing agencies and efficacy testing CROs specializing in the beauty industry. These agencies scale their business through standardized testing packages (moisturizing, whitening, anti-allergy, anti-aging, etc.) + customized solutions (specific populations, specific scenarios). On the other hand, with advancements in dermatology, optical imaging, and microbiome testing, 'how well it works' is no longer just a subjective questionnaire but increasingly relies on high-precision instruments, image analysis, and data modeling, raising the industry's entry barriers. The growth in the next few years will come from two sources: first, the strong demand for efficacy verification from new raw materials and new market segments (such as sensitive skin, anti-aging, scalp care, and feminine hygiene); and second, the spillover demand from domestic brands going global and seeking overseas certifications and clinical data endorsements. Whoever understands regulations, skin, and market language will have the opportunity to upgrade from 'doing tests' to 'being a product strategy and claim design consultant,' thereby obtaining higher unit prices and deeper binding relationships.
