Abstracts

The global Nucleoside Antiviral API market size is predicted to grow from US\$ 2133 million in 2025 to US\$ 3102 million in 2032; it is expected to grow at a CAGR of 5.5% from 2026 to 2032.

Nucleoside Antiviral APIs are pharmaceutical-grade active ingredients based on nucleoside analogues, nucleotide analogues or related prodrug structures, used in the manufacture of antiviral finished dosage forms for herpesvirus infection, HIV, hepatitis B, hepatitis C, cytomegalovirus infection and selected broad-spectrum antiviral therapies. Major products include acyclovir, valacyclovir, ganciclovir, valganciclovir, lamivudine, emtricitabine, tenofovir, entecavir, sofosbuvir and remdesivir. Upstream inputs mainly include nucleobases, glycosylation intermediates, chiral intermediates, phosphorylation reagents, protecting-group reagents, coupling agents, catalysts, pharmaceutical-grade solvents, purification resins, activated carbon and GMP-grade packaging materials. Downstream customers are primarily antiviral finished-dose manufacturers, generic pharmaceutical companies, multinational pharmaceutical supply chains, public-health procurement channels, CDMO clients and regional drug manufacturers. On an ex-works basis, global effective capacity was estimated at about 21,500 tons in 2025, with sales volume of about 14,860 tons and an average ex-works price of around USD 146.7/kg. Mature high-volume products such as acyclovir, lamivudine and tenofovir disoproxil fumarate are generally priced lower, while higher-barrier products such as valganciclovir, tenofovir alafenamide, sofosbuvir and remdesivir command higher unit prices. The industry's gross margin was approximately 28%-42% in 2025.

From the current market perspective, nucleoside antiviral APIs have entered a relatively mature stage, with demand mainly supported by long-term antiviral therapy, common

viral infection treatment and regulated-market generic drug supply. HIV and hepatitis B therapies have strong chronic-use characteristics, supporting stable consumption of lamivudine, emtricitabine, tenofovir, entecavir and related products. Herpesvirus treatment continues to sustain baseline demand for mature high-volume products such as acyclovir and valacyclovir. Overall supply is concentrated mainly in India and China. Indian manufacturers are strongly positioned in antiretroviral APIs and international public-health procurement channels, while Chinese suppliers have competitive advantages in acyclovir, nucleoside intermediates and cost-efficient antiviral API manufacturing.

Looking ahead, market growth will be driven more by expansion of treated patient populations, better access to antiviral medicines in low- and middle-income countries, higher penetration of long-term hepatitis B therapy and product upgrading toward selected high-value nucleotide prodrugs. Mature large-volume APIs are expected to show limited growth flexibility, and price competition among multiple suppliers will continue to compress margins in commodity products. In contrast, higher-barrier products such as tenofovir alafenamide, valganciclovir, sofosbuvir, remdesivir and selected complex prodrug APIs are likely to retain stronger profitability due to more demanding synthesis routes, impurity control, polymorph management and regulatory entry requirements. Future competition will shift from simple capacity expansion to process optimization, quality systems, international registrations, green chemistry and stronger API-formulation integration.

The key market driver is the persistent global need for antiviral treatment, especially in HIV and hepatitis B, where long-term standardized therapy creates resilient API demand. Public-health procurement, international aid programs, generic drug quality requirements, regulatory filing maintenance and multinational pharmaceutical companies' supply-chain diversification are also supporting suppliers with GMP, DMF, CEP or WHO prequalification capabilities. At the same time, many countries are paying greater attention to essential medicine security and localized pharmaceutical supply chains, increasing the strategic importance of antiviral APIs. For leading manufacturers, backward integration into key intermediates, continuous processing, enzymatic catalysis and more selective synthesis routes will be important ways to improve cost competitiveness and supply reliability.

The main constraints come from strong price pressure in mature nucleoside antiviral APIs. Products such as acyclovir, lamivudine and tenofovir disoproxil fumarate face multiple suppliers and strong customer bargaining power, making profitability sensitive to changes in raw material, solvent, energy and environmental compliance costs. High-

value products offer better margins, but process scale-up, regulatory filing, impurity research and customer audits usually require long development cycles, creating higher barriers for smaller companies. Some therapeutic areas also face substitution or demand-cycle risks. For example, hepatitis C demand is increasingly influenced by screening coverage after high cure rates, while event-driven products may experience inventory digestion and demand normalization. Overall, the industry retains a stable demand base, but supplier differentiation will continue to increase, and companies with stronger quality, cost, registration and customer advantages will be better positioned.
