SUMMARY

The UK accountancy market had total revenues of \$39.8bn in 2020, representing a compound annual growth rate (CAGR) of 8.3% between 2016 and 2020.

The advisory segment was the market's most lucrative in 2020, with total revenues of \$15.8bn, equivalent to 39.6% of the market's overall value.

The pandemic caused a shock to leading players' revenue in the early outbreak causing the market to stall but following this the firms recovered and saw a return to growth.
