#### SUMMARY

The US accountancy market had total revenues of \$176.9bn in 2019, representing a compound annual growth rate (CAGR) of 3.2% between 2015 and 2019.

The audit segment was the market's most lucrative in 2019, with total revenues of \$76.7bn, equivalent to 43.3% of the market's overall value.

The 'Big Four' accountancy firms (EY, PwC, Deloitte, KPMG) alleviate market rivalry to a great extent, keeping market growth rates at moderate levels.
