#### SUMMARY

The civil aerospace segment was the market's most lucrative in 2019, with total revenues of \$259.9bn, equivalent to 46.6% of the market's overall value.

The US is the world's largest aerospace and defense market with a global market share of 36.8% and a market value over \$525bn in 2019.
