SUMMARY

Aerospace & Defense in Norway industry profile provides top-line qualitative and quantitative summary information including: market size (value 2015-19, and forecast to 2024). The civil aerospace segment was the market's most lucrative in 2019, with total revenues of \$4.1bn, equivalent to 60.6% of the market's overall value.

In 2020, The Norwegian government has released its Long-Term Defense Plan, aiming to steadily increase defense investment to reach the NATO minimum goal of 2% of GDP by 2028
