#### SUMMARY

Aerospace & Defense in South America industry profile provides top-line qualitative and quantitative summary information including: market size (value 2015-19, and forecast to 2024). #### **KEY HIGHLIGHTS**

The aerospace & defense market consists of (1) the civilian aerospace market and (2) the military aerospace and defense market.

The South American aerospace & defense market had total revenues of \$35.9bn in 2019, representing a compound annual growth rate (CAGR) of 8.4% between 2015 and 2019.

The Civil aerospace segment was the market's most lucrative in 2019, with total revenues of \$17.0bn, equivalent to 47.3% of the market's overall value.

In South America, a perceived lack of external and inter-state threats has meant that military capacity has been focused on non-traditional security concerns, such as organized crime, the illicit drug trade, and humanitarian operations.
