SUMMARY

Aerospace & Defense in Belgium industry profile provides top-line qualitative and quantitative summary information including: market size (value 2016-20, and forecast to 2025). The Belgian aerospace & defense market had total revenues of \$2.7bn in 2020, representing a compound annual rate of change (CARC) of -4.8% between 2016 and 2020.

The civil aerospace segment was the market's most lucrative in 2020, with total revenues of \$1.5bn, equivalent to 58.2% of the market's overall value.

Much of the growth in the market has come from the civil segment, as the military budget has been reduced in recent years.
