SUMMARY

The Brazilian aerospace & defense market had total revenues of \$5.8bn in 2020, representing a compound annual rate of change (CARC) of -14% between 2016 and 2020.

The civil aerospace segment was the market's most lucrative in 2020, with total revenues of \$1.7bn, equivalent to 28.8% of the market's overall value.

Brazil is a relatively conflict-free country but remains the largest military spender in Latin America.
