SUMMARY

The civil aerospace segment was the market's most lucrative in 2020, with total revenues of \$2.4bn, equivalent to 67.6% of the market's overall value.

The Irish defense budget is one of the smallest in Europe, surpassing EUR1.0bn (\$1.12bn) for the second time ever in 2020.
