SUMMARY

Aerospace & Defense in South Africa industry profile provides top-line qualitative and quantitative summary information including: market size (value 2016-20, and forecast to 2025). The South African aerospace & defense market had total revenues of \$1.4bn in 2020, representing a compound annual rate of change (CARC) of -19.9% between 2016 and 2020.

The systems & ordnance segment was the market's most lucrative in 2020, with total revenues of \$473.4m, equivalent to 34.7% of the market's overall value.

Unlike other African countries, such as Algeria, Libya and Nigeria, South Africa has a fairly low-level threat of cross border attacks.
