SUMMARY

The Thai aerospace & defense market had total revenues of \$7.0bn in 2020, representing a compound annual rate of change (CARC) of -10.6% between 2016 and 2020.

The civil aerospace segment was the market's most lucrative in 2020, with total revenues of \$4.8bn, equivalent to 69.4% of the market's overall value.

Thailand faces an insurgency in its southernmost provinces, as well as continued threats in Bangkok and other parts of the country from southern militants.
