The agricultural products industry within the NAFTA countries had a total market value of \$340.7 billion in 2022. The Mexico was the fastest growing country, with a CAGR of 5.6% over the 2018-22 period.

Within the agricultural products industry, the US is the leading country among the NAFTA bloc, with market revenues of \$265.3 billion in 2022. This was followed by Canada and Mexico, with a value of \$38.3 and \$37.1 billion, respectively.

The US is expected to lead the agricultural products industry in the NAFTA bloc, with a value of \$317.9 billion in 2027, followed by Mexico and Canada with expected values of \$46.8 and \$40.5 billion, respectively.
