Air Freight in Brazil

SUMMARY

Air Freight in Brazil industry profile provides top-line qualitative and quantitative summary information including: market size (value and volume 2015-19, and forecast to 2024). The profile also contains descriptions of the leading players including key financial metrics and analysis of competitive pressures within the market.

KEY HIGHLIGHTS

The air freight sector is defined as consisting of revenues generated from freight transportation by air.

The Brazilian air freight sector had total revenues of \$1,280.8m in 2019, representing a compound annual growth rate (CAGR) of 10.6% between 2015 and 2019.

Sector consumption volume increased with a CAGR of 7% between 2015 and 2019, to reach a total of 1,959.2 million FTK in 2019.

Brazil experienced its longest recession on record between 2014 and 2016, with falling commodity prices and political instability. However, normalcy has returned to the Brazilian economy, with annual GDP growth reaching 1.1% in both 2017 and 2018.
