Air Freight in Scandinavia

#### SUMMARY

Air Freight in Scandinavia industry profile provides top-line qualitative and quantitative summary information including: market size (value and volume 2015-19, and forecast to 2024). The profile also contains descriptions of the leading players including key financial metrics and analysis of competitive pressures within the market.

#### **KEY HIGHLIGHTS**

The air freight sector is defined as consisting of revenues generated from freight transportation by air.

The Scandinavian air freight sector had total revenues of \$1,407.1m in 2019, representing a compound annual growth rate (CAGR) of 1.1% between 2015 and 2019.

Sector consumption volume increased with a CAGR of 2.3% between 2015 and 2019, to reach a total of 1,780.6 million FTK in 2019.

The Scandinavian air freight sector's value growth has fluctuated in recent years. The sector witnessed a contraction in 2016; as the largest air freight sector in the region, Finland underwent a 4% decline in exports compared to the preceding year according to the country's customs.
