### Summary

The North American Free Trade Agreement (NAFTA) is a trade agreement between the countries in North America: the US, Canada and Mexico. The air freight industry within the NAFTA countries had a total market value of \$20,118.3 million in 2023. The Canada was the fastest growing country, with a CAGR of 4.4% over the 2019-23 period.

Within the air freight industry, the US is the leading country among the NAFTA bloc, with market revenues of \$17,765.9 million in 2023. This was followed by Canada and Mexico, with a value of \$1,548.8 and \$803.6 million, respectively.

The US is expected to lead the air freight industry in the NAFTA bloc, with a value of \$20,988.1 million in 2028, followed by Canada and Mexico with expected values of \$2,137.7 and \$1,139.9 million, respectively.
