SUMMARY

Airlines in the Netherlands industry profile provides top-line qualitative and quantitative summary information including: market size (value and volume 2016-20, and forecast to 2025). The airlines industry comprises passenger air transportation, including scheduled flights but excluding air freight transport.

The Dutch airlines industry had total revenues of \$4.1bn in 2020, representing a compound annual rate of change (CARC) of -26.9% between 2016 and 2020.

Industry consumption volumes declined with a CARC of -23.9% between 2016 and 2020, to reach a total of 23.6 million seats sold in 2020.

Domestic and international tourism saw a marked decline in 2020 due to travel restrictions and lockdowns.
