SUMMARY

Airlines in Scandinavia industry profile provides top-line qualitative and quantitative summary information including: market size (value 2016-20, and forecast to 2025). The profile also contains descriptions of the leading players including key financial metrics and analysis of competitive pressures within the market.

KEY HIGHLIGHTS

The airlines industry comprises passenger air transportation, including scheduled flights but excluding air freight transport.

The Scandinavian airlines industry had total revenues of \$4.2bn in 2020, representing a compound annual rate of change (CARC) of -28.7% between 2016 and 2020.

Industry consumption volumes declined with a CARC of -26.4% between 2016 and 2020, to reach a total of 36.7 million seats sold in 2020.

Domestic and international tourism saw a marked decline in 2020 due to travel restrictions and lockdowns, which led to a significant decline in the airline industry.
