Airlines in Scandinavia

Summary

Airlines in Scandinavia industry profile provides top-line qualitative and quantitative summary information including: market share, market size (value and volume 2015-19, and forecast to 2024). Key Highlights

The airlines industry comprises passenger air transportation, including scheduled flights but excluding air freight transport.

The Scandinavian airlines industry had total revenues of \$16.1bn in 2019, representing a compound annual growth rate (CAGR) of 3.4% between 2015 and 2019.

Industry consumption volume increased with a CAGR of 3.6% between 2015 and 2019, to reach a total of 131.9 million passengers in 2019.

Growth in the region was primarily driven by Denmark, which experienced the strongest growth overall. Finland experienced only marginal growth historically, the poorest of the four countries.
