The North American Free Trade Agreement (NAFTA) is a trade agreement between the countries in North America: the US, Canada and Mexico. The apparel retail industry within the NAFTA countries had a total market value of \$3,87,439.3 million in 2018. The Mexico was the fastest growing country, with a CAGR of 6.9% over the 2014-18 period.

Within the apparel retail industry, the US is the leading country among the NAFTA bloc, with market revenues of \$3,47,979.7 million in 2018. This was followed by Canada and Mexico, with a value of \$23,375.1 and \$16,084.4 million, respectively.



The US is expected to lead the apparel retail industry in the NAFTA bloc, with a value of \$3,93,932.9 million in 2023, followed by Canada and Mexico with expected values of \$26,236.7 and \$18,690.8 million, respectively.
