The North American Free Trade Agreement (NAFTA) is a trade agreement between the countries in North America: the US, Canada and Mexico. The apparel retail industry within the NAFTA countries had a total market value of \$3,65,364.0 million in 2017. The Mexico was the fastest growing country, with a CAGR of 7.9% over the 2013-17 period.

Within the apparel retail industry, the US is the leading country among the NAFTA bloc, with market revenues of \$3,27,228.0 million in 2017. This was followed by Canada and Mexico, with a value of \$22,201.3 and \$15,934.8

million, respectively.

The US is expected to lead the apparel retail industry in the NAFTA bloc, with a value of \$3,51,549.3 million in 2022, followed by Canada and Mexico with expected values of \$26,565.1 and \$22,766.6 million, respectively.
