The top 5 emerging countries are expected to reach a value of \$5,61,316.4 million in 2022, with a CAGR of 9.7% over the 2017-22 period.

Within the apparel retail industry, China is the leading country among the top 5 emerging nations, with market revenues of \$2,41,538.2 million in 2017. This was followed by India and Brazil with a value of \$52,530.6 and \$35,961.9 million, respectively.

China is expected to lead the apparel retail industry in the top five emerging nations, with a value of \$3,92,833.3 million in 2022, followed by India and Brazil with expected values of \$92,084.8 and \$44,054.1 million, respectively.
