The Argentinian banks industry had total assets of \$170.7bn billion in 2021, representing a compound annual growth rate (CAGR) of 44% between 2016 and 2021.

The bank credit segment was the industry's most successful in 2021, with total assets of \$114.6bn billion, equivalent to 67.1% of the industry's overall value.

Growth in the Argentinian industry is being driven by the implementation of the National Financial Inclusion Strategy 2020--23, which aims to improve access to financial services, enhance financial literacy and consumer protection, and promote interoperability between traditional financial systems and new payment



platforms.
