SUMMARY

BPO Services in Asia-Pacific industry profile provides top-line qualitative and quantitative summary information including: market share, market size (value and volume 2017-21, and forecast to 2026). KEY HIGHLIGHTS

BPO services include revenues generated both from signed deals that remain under contract and the annual revenues associated with new contracts signed within a particular calendar year. The services include the outsourcing of functions such as customer relationship management, knowledge process outsourcing, finance & accounting, human resources, procurement, and vertical-specific processes. The total value of the market represents the demand for the service coming from a particular country.

The Asia-Pacific BPO services market had total revenues of \$69,849.0 million in 2021, representing a compound annual growth rate (CAGR) of 5.6% between 2016 and 2021.

The vertical-specific BPO segment was the market's most lucrative in 2021, with



total revenues of \$18,339.2 million, equivalent to 26.3% of the market's overall value.

Majority of the BPO hubs in the Asia-Pacific market have attained saturation while there are several that are beginning to stride. Smaller cities in India are turning out to be one of the top outsourcing markets with countries such as China increasingly gaining traction as key outsourcing call center destination.
