Summary

The Asia-Pacific cereal crops industry had total revenues of \$408.3 billion in 2022, representing a compound annual growth rate (CAGR) of 5.2% between 2017 and 2022.

Industry production volume increased with a CAGR of 1.3% between 2017 and 2022, to reach a total of 1.13 billion tonnes in 2022.

The Asia-Pacific industry contracted in 2022 owing to a decline in the production value of wheat and other coarse grains (such as sorghum, oats, and millets).
