The Asia-Pacific chemicals market had total revenues of \$3,464 billion in 2023, representing a compound annual growth rate (CAGR) of 6.3% between 2018 and 2023.

The commodity chemicals segment accounted for the market's largest proportion in 2023, with total revenues of \$1,847.5 billion, equivalent to 53.3% of the market's overall value.

Asia-Pacific accounted for the largest share with 64.9% of the global chemical market in 2023, followed by Europe and the US. In the Asia-Pacific region,

China accounted for the largest share with 75.3% of the chemical market in 2023, followed by Japan.
