SUMMARY

Textile Mills in Asia-Pacific industry profile provides top-line qualitative and quantitative summary information including: market share, market size (value and volume 2017-21, and forecast to 2026). KEY HIGHLIGHTS

The textile mills market includes yarns and fabrics. The value of each segment is for consumption, defined as domestic production plus imports minus exports, all valued at manufacturer prices.

The Asia-Pacific textile mills market had total revenues of \$360.8 billion in 2021, representing a compound annual growth rate (CAGR) of 1.4% between 2016 and 2021.

The fabric segment was the market's most lucrative in 2021, with total revenues of \$293.3 billion, equivalent to 81.3% of the market's overall value.

The COVID-19 pandemic, which first took hold in the Asia-Pacific region, in 2019 and 2020, has had a severe impact on the textile mills market, but the market recovered strongly in 2021.
