The commodity chemicals segment accounted for the largest proportion of the market in 2021, with total revenues of \$1,536.3 billion, equivalent to 54.7% of the market's overall value.

The Asia-Pacific region is the largest globally and had a 59.2% share of the global chemicals market's total value in 2021, the majority of which (64.3%) is

accounted for by China.
