SUMMARY

KEY HIGHLIGHTS

The construction market is defined as the value of work put in place annually for both, residential and non-residential construction.

The Asia-Pacific Construction industry had total revenues of \$6,747.1bn in 2021, representing a compound annual growth rate (CAGR) of 7.2% between 2016 and 2021.

The Non-Residential Construction segment was the industry's most lucrative in 2021, with total revenues of \$4,135.2bn, equivalent to 61.3% of the industry's overall value.

Decline in 2020 of 3.8% was due to economic disruption induced by the COVID-19 pandemic. This significantly hampered economic activity and resulted in the cancellation and delays of many construction projects.
