SUMMARY

IT Services in Asia-Pacific industry profile provides top-line qualitative and quantitative summary information including: market size (value 2017-21, and forecast to 2026). The profile also contains descriptions of the leading players including key financial metrics and analysis of competitive pressures within the market.

KEY HIGHLIGHTS

The IT services industry is valued as the combination of the business process outsourcing (BPO) services market, the application services market and the infrastructure services market. Values include revenues generated from (a) signed deals that remain under contract and (b) new contracts signed within that particular calendar year.

The Asia-Pacific IT services industry had total revenues of \$337.6bn in 2021, representing a compound annual growth rate (CAGR) of 10.1% between 2016 and 2021.

The Infrastructure Services segment was the industry's most lucrative in 2021, with total revenues of \$216.4bn, equivalent to 64.1% of the industry's overall value.

Growth in the market has been driven by increased adoption of digital IT services along with the increased prevalence of IT infrastructure in the region.
