Market production volume increased with a CAGR of 1.1% between 2017 and 2022, to reach a total of 127.2 million tonnes in 2022.

The Chinese meat and livestock market is the largest in the Asia-Pacific by far, accounting for 58.1% of the region's overall value in 2022.
