The road segment accounted for the industry group's largest proportion in 2022, with total revenues of \$1,232.8 billion, equivalent to 68% of the industry group's overall value.

The growth in the Asia-Pacific transportation services industry group is influenced by several macroeconomic factors, such as rising GDP and growing business confidence. For instance, according to the Organisation for Economic Co-operation and Development (OECD), the business confidence index in China reached 99.4 in February 2023, up from 97.01 in November 2022.
