Summary

The transportation services industry comprises the air, marine, rail, and road freight sectors.

The Australian transportation services industry group had total revenues of \$85.9 billion in 2022, representing a compound annual growth rate (CAGR) of 2.3% between 2017 and 2022.

The road segment accounted for the industry group's largest proportion in 2022, with total revenues of \$50.8 billion, equivalent to 59.2% of the industry group's overall value.

The growth in the Australian transportation services industry group is influenced by several macroeconomic factors, such as rising GDP and growing business confidence. For instance, according to the Organisation for Economic Cooperation and Development (OECD), the business confidence index in Australia reached 101.73 in May 2022, up from 100.32 in July 2021.
