The road segment accounted for the industry group's largest proportion in 2022, with total revenues of \$6.9 billion, equivalent to 85.8% of the industry group's overall value.

The growth in the Austrian transportation services industry group is influenced by several macroeconomic factors, such as rising GDP and growing business confidence. For instance, according to the Organisation for Economic Co-operation and Development (OECD), the business confidence index in Austria reached 102.78 in January 2022, up from 99.96 in January 2021.
