Sector consumption volume is forecast to increase with a CAGR of 5.9% between 2014 and 2018, to reach a total of 171.4 million units in 2018.

The strong value growth in this sector has largely been the result of the weakening value of the rand, coupled with rising inflation, which has meant that prices in this market have risen. However, demand has also remained buoyant

in this sector despite adverse economic conditions in the country.
