SUMMARY

The NAFTA Automotive Aftermarket industry profile provides top-line qualitative and quantitative summary information including: sector size (value and volume 2016-20, and forecast to 2025). KEY HIGHLIGHTS

The North American Free Trade Agreement (NAFTA) is a trade agreement between the countries in North America: the US, Canada and Mexico. The automotive aftermarket industry within the NAFTA countries had a total market value of \$2,09,709.7 million in 2020. The Mexico was the fastest growing country, with a CAGR of 7.1% over the 2016-20 period.

Within the automotive aftermarket industry, the US is the leading country among the NAFTA bloc, with market revenues of \$1,71,275.7 million in 2020. This was followed by Mexico and Canada, with a value of \$22,738.7 and \$15,695.2 million, respectively.

The US is expected to lead the automotive aftermarket industry in the NAFTA bloc, with a value of \$2,11,991.7 million in 2025, followed by Mexico and Canada with expected values of \$28,518.6 and \$18,552.3 million, respectively.
