KEY HIGHLIGHTS

The North American Free Trade Agreement (NAFTA) is a trade agreement between the countries in North America: the US, Canada and Mexico. The automotive aftermarket industry within the NAFTA countries had a total market value of \$301.7 billion in 2017. The Mexico was the fastest growing country, with a CAGR of 13.1% over the 2013-17 period.

Within the automotive aftermarket industry, the US is the leading country among the NAFTA bloc, with market revenues of \$276.5 billion in 2017. This was



followed by Canada and Mexico, with a value of \$17.1 and \$8.0 billion, respectively.

The US is expected to lead the automotive aftermarket industry in the NAFTA bloc, with a value of \$324.6 billion in 2022, followed by Canada and Mexico with expected values of \$20.4 and \$12.2 billion, respectively.
