The G8 countries contributed \$980.5 billion in 2022 to the global automotive manufacturing industry, with a compound annual growth rate (CAGR) of -2.1% between 2018 and 2022. The G8 countries are expected to reach a value of \$1,266.6 billion in 2027, with a CAGR of 5.3% over the 2022-27 period.

Among the G8 nations, the US is the leading country in the automotive manufacturing industry, with market revenues of \$628.9 billion in 2022. This was followed by Japan and Germany, with a value of \$150.6 and \$69.3 billion, respectively.

The US is expected to lead the automotive manufacturing industry in the G8 nations with a value of \$783.3 billion in 2016, followed by Japan and Germany with expected values of \$176.6 and \$116.5 billion, respectively.
