The Mexico was the fastest growing country, with a CAGR of 3.2% over the 2018-22 period.

Within the automotive manufacturing industry, the US is the leading country among the NAFTA bloc, with market revenues of \$628.9 billion in 2022. This was followed by Mexico and Canada, with a value of \$104.8 and \$49.7 billion, respectively.

The US is expected to lead the automotive manufacturing industry in the NAFTA bloc, with a value of \$783.3 billion in 2027, followed by Mexico and Canada with expected values of \$136.0 and \$69.2 billion, respectively.
