Summary

Key Highlights

The North American Free Trade Agreement (NAFTA) is a trade agreement between the countries in North America: the US, Canada and Mexico. The bakery & cereals industry within the NAFTA countries had a total market value of \$1,96,221.0 million in 2023. The Mexico was the fastest growing country, with a CAGR of 5.2% over the 2019-23 period.

Within the bakery & cereals industry, the US is the leading country among the NAFTA bloc, with market revenues of \$1,43,555.6 million in 2023. This was followed by Mexico and Canada, with a value of \$38,882.7 and \$13,782.7 million, respectively.

The US is expected to lead the bakery & cereals industry in the NAFTA bloc, with a value of \$1,75,093.6 million in 2028, followed by Mexico and Canada with expected values of \$49,199.1 and \$17,928.5 million, respectively.
